#### 2. BIRTH REGISTRATION

Applications can be made either in person or by mail. Please make an appointment on www.konsolosluk.gov.tr for in person appointments.

# **Application Requirements:**

- 1. Either mother or father must be a Turkish citizen.
- 2. Child must be under 18.
- 3. Birth must be in jurisdiction of Turkish Consulate General in Boston (MA, NH, CT, ME, VT, RI).

#### **Required documents:**

- 1. Application form (Encl.)
- 2. Original "Birth Certificate" of the child and 1 copy. ("Birth Record" is NOT accepted.)
- 3. Turkish ID's of both parents and 1 copy; if one of the parents is a citizen of a foreign country, ID (passport and/or driver's license) and 1 copy.
- 4. If one of the parents is citizen of a foreign country, Turkish or English translation of their "Birth Certificate." (No need for translation of English documents.) (Mandatory to have names of both mother and father in the Birth certificate.)
- 5. Original "Marriage Certificate" and 1 copy. (If applicable.) (If parents are married at the time of birth, their marriage must be registered prior to the birth registration.)
- 6. 1 biometric photo, if child is over 15. (Only applicable for in person appointments)
- 7. Petition for leaving the section for "Religion" blank in Turkish ID, if desired. (Encl.)
- 8. Dual citizenship form (Encl.)

#### Fees:

- \$35 for your documents to be mailed to Türkiye.
- If registering within 60 days of birth, \$5 for Turkish ID. If applying later than within 60 days of birth, \$9,50 for Turkish ID. If you lost your ID, the fee is \$13,90.

# **Application Method:**

- If you are applying by mail and would like to have all documents you submitted returned to your address, you will need to include a pre-paid envelope with your address and tracking number to your mailed documents.
- Notarized copies of original documents are also accepted for applications by mail.
- For the child who was born in marriage unity, one of the parents can apply.
- If the child was born outside of marriage, both parents must apply.
- If applying by mail, you may not apply for an ID. Do not add any photos to your mail applications since ID applications can only be done in person.

#### **Additional information:**

Application fee can only be paid in cash (in person applications) or money order (mail applications) payable to the Turkish Consulate General in Boston. Personal or company checks are not accepted.
