

### 3. MARRIAGE REGISTRATION

Applications can be made either in person or by mail. Please make an appointment on [www.konsolosluk.gov.tr](http://www.konsolosluk.gov.tr) for in person applications.

Marriage must be in jurisdiction of Turkish Consulate General in Boston (MA, NH, CT, ME, VT, RI)

#### Required documents:

1. Application forms (Encl.).
  2. 2 passport sized photos of both partners. (if a marriage book is desired.)
  3. Original "Marriage Certificate" and 1 copy. ("Marriage Record" is NOT accepted.)
  4. Turkish ID's of both partners and 1 copy.
  5. If one of the partners is not Turkish, foreign spouse's original birth certificate and passport or their notarized copies, and 1 copy. If there are differences in the birth certificate and passport, supplementary documents must be submitted to prove the change. If the birth certificate is in any other language than Turkish or English, a certified and notarized translation to either of these languages is required.
  6. Form for maiden surname, if the woman would like to adopt her maiden surname (Encl.) (Only applies if both partners are Turkish)
  7. Court decision or death certificate for previous marriages, if applicable.
  8. If you would like to have all documents you submitted returned to your postal address, please include a pre-paid envelope with your address and tracking number.
- Notarized copies of original documents are also accepted for applications by mail.

#### Fee:

1. \$35 for your documents to be mailed to Türkiye.
2. \$24 for Turkish Marriage Book, if desired. (Uluslararası Aile Cüzdanı)

**Important note:** It is mandatory to submit notarized (notary public) translations of documents, written in languages other than Turkish and English.

**Additional information:** Application fee can only be paid in cash (in person appointments) or money order (mail appointments) payable to the Turkish Consulate General in Boston. Personal and company checks are not accepted.
